MEMORANDUM FOR ALL UNITED STATES CYBER COMMAND PERSONNEL

SUBJECT: Star Note and Senior Leader Coin Recognition Program

1. (CUI) **Purpose.** This Command Policy Memorandum outlines the eligibility, submission procedure, and timeline for requesting "Star Notes" and coins from the Commander, Deputy Commander, and/or Command Senior Enlisted Leader.

a. (CUI) Star Notes and coins are a part of the command recognition program that awards both military and DoD civilian members throughout the command for an accomplishment that is unique and clearly contributes to increased effectiveness or efficiency of service.

b. (CUI) Star Notes and coins should not be considered in lieu of traditional awards and decorations as outlined in Ref. A.

2. (CUI) **Eligibility.** To nominate a candidate for recognition, the supervisory chain ensures job performance is commensurate with eligibility requirements, and Directorate leaders (O6 or equivalent or above) approve their nominees. To submit for a mission accomplishment award, the nomination must include a justification for how the accomplishment was unique and clearly contributed to increased effectiveness or efficiency of service. Nothing in this policy limits the ability of the Commander, Deputy Commander, and/or Command Senior Enlisted Leader from awarding an eligible recipient without a nomination. U.S. military members or DoD civilians assigned, attached, or detailed to USCYBERCOM (or a unit assigned to USCYBERCOM) are eligible to receive Star Notes and coins.

3. (CUI) Star Notes and coins may NOT be presented to contractors. All coins shall be awarded in accordance with Ref. B.

4. (CUI) **Submission Procedures.** Submitters can find examples and templates on the USCYBERCOM Senior Enlisted Leader website (Go SEA). Additional, general staff package guidance can be found in Ref. C.

5. (CUI) **Timeline.** All Star Note and coin requests must be submitted to the Command Secretariat two weeks prior to the scheduled (or anticipated) presentation date. The Command Secretariat will notify the submitter when the signed Star Note and/or coin are ready for pick-up. Requests received within 14 days of the anticipated presentation will be accompanied by a memorandum to the Chief of Staff from the first O6 or equivalent (or Directorate Leadership) in the awardee's chain of command explaining the late submission.

7. (CUI) This CPM is effective upon signature. This CPM expires one year after signature or until incorporated into a new or existing USCCI.
